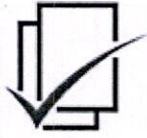

Assumptions & limitation of scope and review:

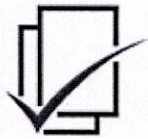

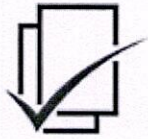
